General Business Policy and User Regulations for the Adventure Park of Schroecken (AGB of Josef Staggl, 6888 Schroecken, Heimboden 104

- 1. Each participant must read the user regulations before entering the Adventure Park. With his signature he confirms to know about these terms, understands them and agrees with them. The guardian of minor participants must read and explain the rules to them before they can enter the Adventure Park. With his signature the guardian confirms that he read through these terms and discussed them with the minor participants and they agree with them. The names of the minors together with their date of birth can also be written on the back side of this form.
- 2. The use of the high wire garden is associated with danger and is at your own risk. Failure to follow the safety rules can lead to falls and injuries. It is also possible that your clothes can get soiled or stained, for example by resin.
- 3. Josef Staggl, as the operating authority, is only liable under the law for persons and property damage by culpable negligence of the operating authority or a staff member.
- 4. A person can use the Adventure Park only if not suffering from a disease, mental or physical impairment, which represents a danger for their own health or that of other persons. People who are under the influence of alcohol or drugs are not entitled to enter the Adventure Park.
- 5. The course "Wasser" (water) and "Wald" (forest) are open to adults and children over the age of six accompanied by a parent or guardian.
- 6. The course "Himmelreich" (heaven) is intended for adults and children with the minimum age of twelve accompanied by a parent or guardian.
- 7. Young people, age 14 or older, can use all stations with a written permit and supervision from the ground by a parent or guardian.
- 8. When using the Adventure Park it is not permitted to carry objects that can be lost and a danger for the participants themselves or others (e.g. jewelry, mobile phones, cameras, backpacks, etc.).
- 9. Each participant must complete the full theoretical and practical safety demonstration class before using the adventure course. All instructions and decisions of the operating authority/employee shall be binding. In case of infringements or violations of the safety instructions or the requests of the operating authority/employee those concerned can be excluded of the Adventure Park. Upon infringements or violations of the safety instructions or the requests of the operating authority/employee Josef Staggl accepts no responsibility for related damages.
- 10. The rented equipment consisting of helmet, harness, safety lines with carabiners must be used according to the instructions of the operating authority/employee. It is not transferable to others and may not be removed while using the Adventure Park, but needs to be returned at the depot before leaving. After a toilet break in between the correct adjustment of the harness must be reviewed by an authorized staff member.

The safety carabiners must always clip onto the red safety wire towards one another. Changing requires at all times one carabiner being still mounted onto the red safety wire or ring. Dismounting both safety carabiners from the red safety wire at the same time is strictly forbidden.

- 11. Each station may only be used simultaneously by one person. On the platform or the beginning of the individual stations there is a maximum of 3 people at the same time permitted.
- 12. The company management reserves the right to exclude people, who do not follow the regulations, from the Adventure Park. The company management reserves the right to suspend the operation for safety reasons, such as storms, heavy rain fall, thunderstorms. In this case there will be no refund of the admission fee. If the guest terminates the visit to the Adventure Park early on his own desire there is also no refund of the admission fee. By debatable weather the visitors are advised to call or get information via the internet about the opening hours. The operator is not liable in case of weather related sudden changes of the opening hours.

The tickets are not transferable. The maximum duration period using the Adventure Park is 3.5 hours.

- 13. Payment is cash in advance. Groups may request an invoice.
- 14. Reservations for groups can be considered only if the Adventure Park management has a written registration stating the number of people attending and the operating authority of the Adventure Park has re-confirmed it in writing. A cancelation of booked groups is made according to the contract rules which have been disclosed prior completion.
- 15. Josef Staggl reserves the right for the entire Adventure Park for taking photos, film or publicity shots for promotional and information purposes. Visitors are permitted the right for promotional purposes only by prior arrangement.
- 16. Only the law of the Republic of Austria applies.
